Who: MAYSA is an organization set up to provide summer ASA softball tournament play for teams in age levels 10U, 12U, 14U, 16U and 18U. Age level is determined by a girl's age as of January 1.

Cost: There will be a \$50 per player registration fee due at the sign-ups which will be refunded in the event that the player is not offered a position on a team. Please be aware that each parent and player is expected to volunteer for a minimum of 4 hours at both Triple Play Tournaments on any concession, field maintenance, preparation or purchasing committee. There will be additional costs and fundraising to be done by each team to raise the money for tournaments and other expenses. A MAYSA branded item will be provided to each player. (Item yet to be determined) Players may still purchase and customize sweatshirts, pants or other MAYSA logo items.
